Neighborhood Watch —Larry Stephey

We're off to a quiet start for 2018. Nevertheless, we have had so far this year, at least four potentially fraudulent telephone calls: two for perceived computer virus/malware issues and two reduce your credit card dept. The only thing in common is that the Call-ID showed them as being local. When asked, one of the callers said they were calling from Atlanta, even though the ID said Winter Park.

The governments, Federal and State, are looking at the robo call issue and hope to pass new regulations to either prevent or at least slow down the number of these calls. Perhaps the callers know this and they are pushing their "business" to make as much as they can before the wall comes down.

I know I have written about this before, but these calls present the biggest risk to our financial well-being at the moment.

Note, the information displayed on your caller ID may not be correct. It is possible to "spoof" the data and display as a friend or a neighbor. The voice you are hearing may not be live as it could be a recorded computer voice. Those calls often start with "this call is being recorded."

If you see suspicious activity in the neighborhood, call the non-emergency number of the Seminole Sheriff Department (407-665-6650). If you see a crime in progress, call 9-1-1.

And please remember to let us in Neighborhood Watch know so that we can track and notify the remainder of Winter Woods.
