Holiday Decorations—Debra Stephey

The evening of December 16 was cool but bright with many holiday decorations as the Winter Woods Decorations committee started their search to find the best-decorated homes in Winter Woods. We are happy to report that the spirit of holiday decorating was very much alive in Winter Woods with over 110 homes participating!

We found numerous homes qualifying for award consideration. After much discussion, the final results from the collection of top displaying homes yielded this year's winners. We were pleased to be able to award the top awards to residences which had never won before! The **Glass residence**, **1739 Nottingham**, was the choice of committee members for the "Over-the-Top Award" and the **Haggerty household at 1960 King Arthurs** won the "**Santa's Choice Award**". The presentation at the **Raida residence**, **1810 Poinciana**, won the "**Committee's Award**". The **Schuermann household at 2118 Poinciana** was the winner of the "**President's Award**". Winners were presented with a sign for display on their front lawns during the remainder of the holiday season. <u>Your household had to be a 2018 paid member of the Winter Woods Homeowners Association in order to be considered for the four top awards. Cash prizes are no longer given to the award winners.</u>

Many houses showed off the outstanding decorating efforts of the residents and received Honorable Mention, and the following is a list of those homes. The houses at 2233, 2238, 2239, and 2251 Coventry looked great. The Hampton Circles had many nice decorations, and we were appreciative of the displays at 2131, 2132, 2137, 2143, and 2149 North Hampton as well as 1918, 1925, 2027, 2028, 2052, and 2146 East Hampton. On Japonica, the displays at 1907, 1921, 1928, 1935, 1949, 1956, 1977, 1985, and 2019 were all delightful. King Alpines was represented by house numbers 2201, 2214, 2225, and 2226. We found nicely decorated homes at 1952, 1953, 1957, 1961, and 1964 King Arthurs. King Charles had wonderful displays at 2209, 2215, and 2227. King Edwards addresses that were represented included 2247, 2263, and 2266. King Henrys had beautiful displays at 2257, 2264, 2269, 2272, and 2276. King James had houses at 2244, 2250, 2256, and 2268 shining brightly. The homes on **King Johns** at 2241, 2247, and 2252 were lit up as well. The houses at 2218 and 2236 King Richards made honorable mention. In addition, those displays at 1519, 1534, 1535, 1551, 1560, 1565, 1621, 1825, 1928, 1943, 2053, and 2131 Nottingham were all noticed. Poinciana looked good with decorations of note at 1843, 1853, 1887, 1955, 1958, 1965, 2047, 2057, 2077, 2080, 2089, 2097, 2212, 2245, 2246, 2251, 2252, 2312, and 2316. Sussex was well represented with homes at 2032, 2033, 2036, 2037, 2041, 2086, 2095, 2096, 2157, 2158, 2165, 2177, 2185, 2189, 2223, 2226, 2232, and 2238 all deserving mention, as well as 2255 Tamerine. Displays worthy of Honorable Mention on Winter Woods Blvd. were 2206, 2207, 2212, and 2224.

<u>Committee members had difficulty locating the house numbers on many homes in Winter</u> <u>Woods</u>. <u>If your house was decorated but not noted, it could be because we were unable to</u> <u>locate a house number!</u> We encourage all residents to make sure your address numbers are visible from the street at all times so that your home can be quickly identified by emergency responders! This is a safety issue far more important than holiday decorations.

We applaud the efforts of all homeowners who took the time to decorate for the holiday season and brighten up our neighborhood. In addition, sincere appreciation goes out to Cheryl Smith for storing the award signs year around, as well as to those residents who served on the Decorations committee. Thank you everyone!




