ARE YOU A VETERAN?

Recently, the US Congress passed the Legion Act. This legislation changed the eligibility for membership in The American Legion. Now <u>all</u> Veterans, regardless of the period in which they served, are eligible for membership in The American Legion. The local American Legion Post, Winter Park Memorial Post 112, meets the second Tuesday of each month at 7pm and they would love to have all interested Veterans join their active, community service oriented organization. The Post is located at 4490 North Goldenrod Road, between Aloma Avenue and University Blvd. For more information about The American Legion, please call the Adjutant, Bob, at 407-619-9611.

And just as The American Legion's membership eligibility has changed, so has eligibility for the American Legion Auxiliary. In the past, the American Legion Auxiliary was limited to the wives, mothers, grandmothers, daughters, and granddaughters of Legionnaires or deceased Veterans. At the annual National American Legion convention held in August, the Legion membership voted to change the word "wife" to "spouse" which makes the male spouses of female Veterans eligible for Auxiliary membership. American Legion Auxiliary Unit 112 would like to invite anyone eligible for Auxiliary membership to join them at their next meeting on October 15th at Post 112 beginning at 7pm.
