NEIGHBORHOOD WATCH—Larry Stephey

No reports to us of any criminal activity in the neighbored during the past month. If you become aware of any, please notify Neighborhood Watch here in Winter Woods.

While not technically a Neighborhood Watch issue, we have had more reports of trash bag intrusions. Waste left at the curbside is considered by law enforcement to be abandoned property, so it can be perused by a passerby. It does not help though, if it is not picked up the next morning as is expected.

We have been having quite a few missed pickup days since the start of the pandemic. Our current contracted company, Advanced Disposal, seems to be having some issues. Seminole County, unfortunately, lets out the trash pick-up contracts for ten years at a time and our company has six or seven more years to go.

When such missed days occur, it does help to file a complaint. To make a complaint, contact Seminole County Solid Waste Management at 407-665-2260. They will remind you that the contractor has until 8 P.M. on the scheduled day to meet the requirement. However, if the scheduled route has not been made by the next morning, you can make the call.

The complaints are tracked and hopefully will make a difference. We have a right to expect the service we pay for.


