# Buyer Beware—Bob Colbert

Watch out for those "TAX CREDITS" and SALES PRESSURE.

Many of us are retired or on fixed income, so we watch the pennies. And, when someone comes around to sell something like solar panels or replacement windows, they often refer to "TAX CREDITS" to get some of the cost back. But there is a "caveat" that they may not think of, and neither would you, especially if the salesperson has a dynamic personality. There could be a catch! Think about how much you paid in Income Tax last year, or how much you got back. In many cases, if you didn't pay into the IRS the amount of the credit, you can only get back what was paid in. This may or may not apply, but you need to check. AND THE SALESPERSON IS NOT YOUR TAX ATTORNEY!!!! And, neither am I. Every case is different, so you need to check it out! Often the salesperson will tell you that you can make your purchase and send them the "lump sum" of your "tax credit" to offset some of the cost of a loan. If you don't pay this "lump sum" you may have a substantially higher payment to make. PLEASE WATCH OUT FOR THESE ALTERNATIVES and remember "Murphy's Law." Your tax attorney or accountant can tell you what repairs or improvements are eligible for TAX CREDITS, so please check with them.

Salespeople are there for one reason – to make the sale! If it is a major change for your home, get another estimate! If the salesperson says that this is a **LIMITED TIME OFFER**, there is something wrong and you should view this as a possible RED FLAG. If possible, always get at least one other estimate on any major repairs or improvements.

The term "buyer beware" applies more today than ever before. Don't get stung. "Buyers remorse" can have lasting effects.

# **NEIGHBORHOOD WATCH—Larry Stephey**

Recently, we were made aware that postal regulations require a 30-foot clearance (15 feet either side) around mailboxes to facility delivery. The rules are particularly necessary up north in the winter to keep snow away from the delivery locations. However, cars and trash containers placed too close to delivery locations are also in violation. Here in Winter Woods, we have both street and front porch delivery points. It is, of course, on those streets that have boxes where the rule is applied. If blocked, postal delivery can be delayed until clearance is restored.

In other news, with the current trend of police criticism, law enforcement may be more reluctant to approach suspicious persons without a definite reason. One definite reason to approach is a citizen complaint. If you hear or see a potential crime in progress, you should contact the Seminole County Sheriff's Office with your information. Using your own judgement, a call to 9-1-1 or the non-emergency number of 407-665-6650 can be made. A report from you will give law enforcement the justification to contact an individual and "get acquainted." Seminole County deputies have been trained to approach individuals in a non-threatening manner to gather information and perhaps record a license plate and/or the name of an individual. Even if the deputy has no current knowledge of a crime, the information they record may prove invaluable if later a crime in the area is reported.

# **Holiday Safety Tips**

It's that time of the year when we begin to think about the holidays—our decorations, shopping for those special holiday gifts and traveling to see loved ones that we may have not seen in quite a while. Here are some simple tips—what others do you think need to be mentioned?

- If you have a live tree in your home, be sure it always has plenty of water and only have the tree lights on when you are at home.
