PRESIDENT'S KORNER

The Neighborhood Night Out, held Thursday, October 6, was very successful. While folks did come and go, we probably had more than 60 residents show at one time or another. The bounce house did draw the younger families and it was good to see the youngsters that are growing up in Winter Woods. About 50 hot dogs were served and eaten. Our thanks to Board Member Anna Swenson who advocated for the bouncer and the dogs. It turned out to be a good draw.

Hurricane Ian brought flooding to places in Winter Woods that we had never before seen. Much of the southern half on Nottingham was under water, with some levels reaching into homes and cars. Page 5 The storm sewer drainage pattern is complex with a retention pond behind the southwest corner of Sussex and Poinciana. That pond and apparently sewers on Nottingham drain into ponds on the Interlachen Golf Course. It would seem that overflows there caused flooding on Nottingham and Lake Howell roads.

The storm happened on Thursday, September 29 and the Seminole County was notified of the flooding on Friday, September 30. Based upon email Page 8 that I received, the County reviewed the situation • on Tuesday, October 4. As we know, the water was down by then and the County closed the case on Thursday, October 13. While serious to some, our experience was minor compared to other parts of the County and the area. It may be on somebody's long term project list, but I don't think we will see any changes in the near term. Fortunately, storms like lan are very rare here.

The sanitary sewer issue that had Casselberry asking us to sparingly flush our toilets was caused in part by sewage lift stations, such as we have on Nottingham, being over flooded with stormwater. Normally, stormwater runs Cont'd on Page 2

into its own system and does not fall into the sanitary sewers. However, once in the system, the effluent needs to be treated as if it were sewage. That takes time and the overflows caused Casselberry to issue their cautionary messages.

Yard trash pick up has become a problem again. As of this writing they have missed three weeks in a row. The Seminole County Solid Waste Management website was stating that normal garbage, recycle and yard waste pickups would function as normal while the storm damage collections would be a long-term process. When I pointed out our yard waste issue, they changed the website.

The General Membership meeting was poorly attended with only one non-board member guest. We are going need greater participation from our neighbors if the HOA is to survive.

NEIGHBORHOOD WATCH—Larry Stephey

As mentioned elsewhere, the turn out for Neighborhood Night Out was excellent. The two Seminole County deputies spent a sizable part of their evening answering questions and showing the young-sters the attributes of the patrol cars.

One of the deputies asked me to remind Winter Woods residents of the Seminole County Sheriff Office House Watch program. It is a program that has been in effect for some time, but there seems to be a new requirement.

You can search for details at SCSO House Watch. There you will see the service is for vacations and vacant homes. It used to be a simple request, but now a form must be completed, and a deputy will stop by to retrieve the form. The process can also be started by calling the SCSO non-emergency number of 407-665-6650.

Once requested a deputy will make periodic checks at the requested residence "to check on the home, driving by to look for anything that might be unusual, and walking around the property to ensure it is secured." The form to be completed does provide more detailed information.

In other events, we had another parked car damaged by a careless driver. This time on Sussex in the early morning hours of Monday, October 3. The responding deputy estimated the driver was traveling about 45 MPH when he collided with a parked van at 2173 Sussex. Both the van and the car were heavily damaged. A near-by streetlight (which is now repaired) was out and may have contributed to the accident, but excessive speed was the primary cause.

The streetlight issue is important because they do contribute to a safer neighborhood. Review your annual property tax bill and you will see a charge for the streetlights in the area. If you notice that a light is out, that information can be reported directly to Duke Energy on their website. Board Member Greg Pfister will also be glad to take your report. His contact information is included in this newsletter.




