STREETS & LIGHTING—Greg Pfister





NEIGHBORHOOD WATCH—Larry Stephey

As mentioned in the November Winter Woods News, the Seminole Sheriff Department had stepped up patrols in Winter Woods during the last few weeks in October. Lt. Robert Smith of the Eastern District, headquarters in Oviedo, tells us that there were "18 area patrols since 10/26 with a total of 9 violations, all for stop signs. Deputies have found that most traffic is within 5mph of the posted limit during peak hours and low traffic during off hours."

Now that we are firmly in the holiday season, the typical warnings need to be made. Be careful walking to your car with packages. When moving on to the next stop, keep packages out of sight as much as possible. Try and leave extra time for nighttime driving.

As always, please report any Winter Woods neighborhood incidents so that we might warn others of crimes within our community.
