## Membership Information

Winter Woods has a vibrant and active Neighborhood Association, and we encourage all our residents, both home owners and renters alike, to join annually. While memberships are accepted throughout the year, our membership year runs from January to December so even if you become a resident of our beautiful neighborhood mid-year or later, we would love to have you join us as soon as you move in to the neighborhood. Our annual Membership Drive runs from January 1 through March 31.

Membership in our association is **voluntary** and we have one of the lowest dues rates in the metro Orlando area. But also keep in mind that for the tiny amount of \$25 per year, your association promotes our community garage sales, and prints our monthly newsletter. We also provide light snacks and kid-friendly activities for the October National Night Out event for residents who come out to get to know their neighbors. Your membership dues also pay for the upkeep on the signs at all the entrances to our great neighborhood along with the signs we use to identify the Yard of the Month and, of course, those really cute signs that our “Holiday Elves” put out to recognize our holiday decorating contest winners. There are no cash awards for Yard of the Month or the holiday decorating contest, so the yard signs are the only recognition residents receive. That’s quite a value for a small amount of money. If you’re like most folks, you’re looking for bargains and membership in YOUR Homeowners Association is one of the best bargains around! And please remember – membership in our neighborhood association is not limited only to homeowners. **We welcome and encourage all those who rent homes in our community to join our association as well.**

Below is a remittance slip that you can use for submitting your dues payment – please clip out the form and be sure to complete **all** the information on the slip, including your **phone number and email address** so that your membership dues payment can be properly recorded. We especially need your **email address** if you have one so that we can update our membership database. In the past, we’ve notified our residents of important information you need quickly via email. AND – if we have your email address, you’ll receive the neighborhood newsletter via email, often before our volunteer newsletter carriers can get it to your door, plus, the emailed newsletter is in color and may have additional pictures that are not included in the carrier delivered version!

Please take a minute right now while you’re thinking about it – grab your checkbook and write out your check for \$25.00 payable to WWHA, fill out the remittance slip, drop them both in the envelope, slap on a stamp, and drop the envelope addressed to WWHA, PO Box 342, Goldenrod, FL 32733-0342 in the mailbox. If you’d prefer to save the stamp, as always, you’re welcome to drop off your dues check at our Treasurer’s home at 1958 Poinciana Road. If you’d prefer to pay using your PayPal account or your credit/debit card, you can – just follow

the link below and then click on the link to pay your dues. While our dues are \$25, there is an additional amount added that covers the convenience fee charged by PayPal for processing. Click on the link below – if you do not have a PayPal account, you can click the “Check out as Guest” button to add your credit card information.

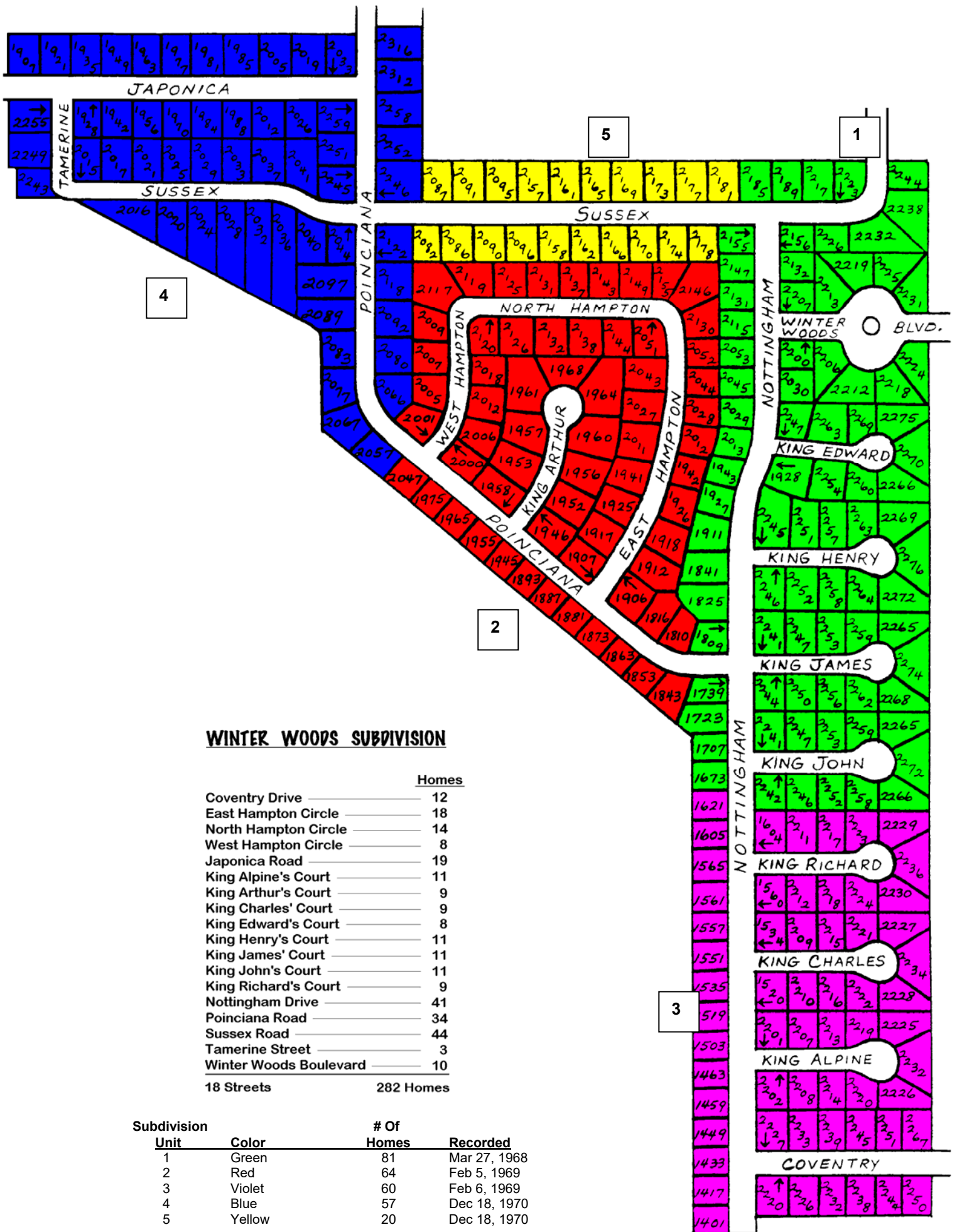
