NEIGHBORHOOD WATCH—Larry Stephey

There were no reported criminal incidents since our last newsletter in June. Winter Woods continues to be one of the safest neighborhoods in one of the safest counties in Florida. With the active participation of all of our residents, we can continue to be so. Just please be on the lookout for suspicious events and report them to the sheriff on their non-emergency number of 407-665-6650. Please let Neighborhood Watch know that you have made a report.

Our next Neighborhood Night Out is slated for Thursday, October 3. This meet and greet event helps the neighborhood be safe by allowing the WW residents to become acquainted with each other. Crime prevention studies have shown that neighbors who know each other do a better job looking out for each other and are more likely to report suspicious events.

We have been asked to remind residents that parking across sidewalks while in a driveway is a traffic violation. You could be issued a parking ticket. Doing so, forces walkers to divert from the sidewalk and into the street to avoid the obstruction. It also could be a stumble hazard after dark if the obstruction, such as a trailer hitch, is unseen.

According to Florida Statute 316.1945(1)(a)(2), it is illegal to stop, stand, or park a vehicle on a sidewalk. This includes driveways, as the sidewalk extends across them even if the pavement changes. Blocked sidewalks can force pedestrians into the road.

In September I'll be calling Seminole County streets department to see what plans they have for Poinciana Road and any other updates.

Lighting; Month to date we have called in Street light outages at 2015 Sussex Road. As far as Winter Woods Boulevard goes, they have fixed two lights on that road and I have called in another one to get fixed.

Sidewalks; As reported last month Winter Woods Subdivision is going to get all sidewalks inspected by Seminole County's sidewalk contractor. They told me they're not sure when they're coming but they have been notified.

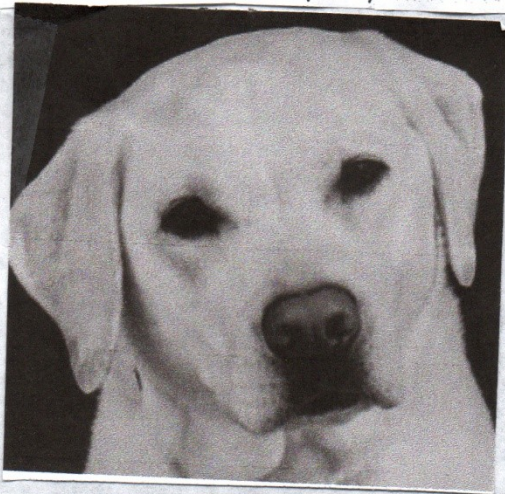

Like many of us, Kathleen and Kyle Klinger were drawn to Winter Woods because it's quiet, established, and while you are close to everything, it's still a safe area. And they like that the HOA keeps everyone connected with the newsletter, Facebook group, and events. "We found our petsitter – Zuzana in the newsletter," said Kyle, "and we have so many really friendly neighbors, many of whom have lived here for years and years."

Kathleen, who grew up in Charlotte, N.C., is a social media manager at Full Sail and Kyle, originally from Bethlehem, Pennsylvania, works in accounting operations at a law firm. When they first moved from Baldwin Park into their house on Nottingham in 2022, it was shortly before they were married, so they wanted to modernize it and make it their own. They knocked down a few walls, installed herringbone floors and new kitchen cabinets. They've done many of the projects themselves - from demo (which was fun!), painting the entire interior and exterior, the kitchen tiles, floating shelves, and wallpaper in the bathrooms.

Fitness and friends drive many of their interests. They train for running races, enjoy plant-based cooking and traveling to see friends because most of their friends and family are elsewhere. They enjoy the outdoors, music shows, going to the beach, hiking, and relaxing in their pool.

You may have seen Kathleen and Kyle walking their greyhounds in the neighborhood but what you may not know is their love of dogs runs deep, very deep.

Let's start with their adopted Greyhounds Windy and Murphy, "We've had Windy for 4 years and Murphy for just about 2," said Kathleen. "She's so sweet and he's goofy and playful." And they foster for Gold Coast Greyhounds and Greyhounds in Motion including 7 dogs since last March alone.

They're always looking for dog-friendly things to do around town, they visit the Baldwin Park dog park and explore dog friendly beaches on both coasts when it's not too hot. Knowing how much they enjoy dog-friendly outings, they started dreaming about opening a place of their own.

Five years in the making, in September they are opening Barkhaven, their dog park bar at 724 Brookhaven Dr., in Ivanhoe Village near Mills 50. Right on the urban trail, the site has many fun options for dogs and people alike; two large dog play areas including one indoor air-conditioned space and an outdoor off-leash area, relaxing garden with firepits, food truck, dog grooming, full-service bar, gourmet coffee, 17 TVs to catch your favorite team, and internet to work remotely while your dog plays. Launching a business while working full-time jobs wasn't easy but they're excited. "We've learned so much and done things we never thought we'd do. We have a great team that has put in a lot of sweat equity for what feels like forever!" said Kathleen.

Humans are always free at Barkhaven, it's the dogs that have memberships! Annual memberships are available in pre-sale now, and once they open, they will have monthly and day passes too. "But you don't need a dog to stop in, if you're on the urban trail, you can pop in, drop your bike on the rack, and come in and relax," said Kyle, "We'd love to have all our neighbors stop by and check it out!" Winter Woods Force Main Replacement

In your June water bill came a printed newsletter from Casselberry Utilities discussing their water quality and other items of interest. There they noted a planned "Force Main Replacement" which will impact some residents in Winter Woods.

Next to the house located at 1534 Nottingham is a large pump station for the sanitary sewers serving Winter Woods and neighboring communities. When effluent enters the sewer system from your home it runs by gravity to this pump, called a "lift station." There the effluent is pumped and pressurized and sent on its way to the area water treatment plants. The underground pipe which contains this transported effluent is called a "force main." Currently, the force main, which has been in place for more than 40 years, runs through some backyards on its way to SR 436, north of Howell Branch Road.

Casselberry now has plans to replace the force main with new pipes and a new route. This new route will run north along Nottingham and then east on Winter Woods Blvd. **Lawns along this route may be impacted and those residents may be inconvenienced during the construction which is slated to begin in late November or early December.**

Employees of Casselberry Utilities are planning to attend the WW HOA General Membership meeting on Thursday, October 10, to explain the procedures and the possible impacts. Interested residents and those who could be impacted are strongly encouraged to attend this meeting for replacement plan details.
