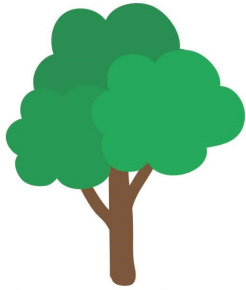

Yes! We welcome our renting neighbors to join the HOA.

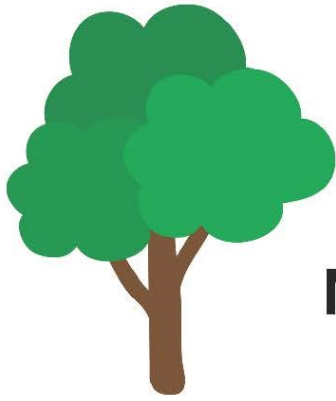
The goal of the HOA is to make the neighborhood a great place to live.

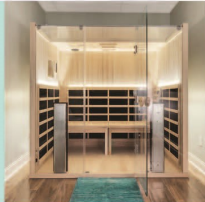

Winter Woods has been around since the late 1960's and there aren't too many original residents left these days. However, on King Johns Court, there is one original family. Mark and Carrol Walz. Carrol grew up in her now home on King Johns and Mark grew up in the immediate area. In fact, Carrol's parents bought their house brand new and she grew up in the house that her and Mark now own and live in.

Mark grew up in Lake Ann Estates, off of Howell Branch, went to East Brook Elementary and Lake Howell High School. They were married in 1988 and bought the home on King Johns Court from Carrol's father and have lived there ever since.

Mark and Carrol raised two sons in their home; Stephen and Alex, who both live in the area. Between these two sons, Mark and Carrol have 3 happy grandchildren.

Way back in 1969, Carrol's sister Ann planted two live oaks in their front yard. Back then, the trees were one foot tall. These trees have grown to over 80 feet in height and provide shade to neighbors on either side of them as well as across the street. Mark has dedicated about \$1,000 per year on tree services to keep these two fine specimens in tip-top shape.

Carrol and Mark have extensively remodeled their home over the years. Mark mentioned that the homes in Winter Woods are very well engineered and built. The block and truss design as well as the materials and the workmanship has allowed them to knock out walls and enjoy an open floor plan. In fact, they are planning on more remodeling in 2025. This time exterior; adding a portico and other features.

Mark mentioned that he feels that Winter Woods is the safest neighborhood in Seminole County, and he is very, very happy with his and Carrols choices. They are also happy to see so many young families moving into the neighborhood. They were children that grew up here, they raised their children here and are glad to see so many children now enjoying Winter Woods for years to come.

Based on theme and design, creativity, and effort and participation, four award winning homes were chosen. We were pleased to be able to give the top awards to the following residences:

The home of Bobby Thollander and Kevin Fox at **1401 Nottingham** was the unanimous choice of committee members for the “**Over-the-Top Award**”!

The display at the home of the Ward family at **2201 King Alpines Court** was the winner of the “**Committee’s Award**.”

Winners were presented with a brand-new sign for display on their front lawns during the remainder of the holiday season. 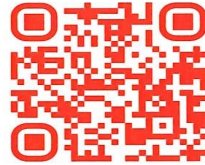
